RELEASE AND WAIVER OF LIABILITY (A form and signature are required for **EACH** participant):

I am aware that bicycling is an athletic event which poses potentially serious risk of injuries or death to its participants. I understand that I may be injured or die as a result of my negligence, the negligence of others, or through no fault of myself or anyone else because of the nature of the activity in which I am going to be engaged. I also understand that bicycles ridden on public and private roads are often difficult to control because of road and weather conditions. With this waiver I accept notice of the risks involved in riding bicycles on public and private roads. The waiver shall remain valid for the within named events, on the Between the Waters Tour weekend, October 21, 22 & 23, 2011, unless expressly revoked by the participant or parent or guardian of a minor, in writing, with receipt acknowledged by Citizens for a Better Eastern Shore, the operator of the Between the Waters Tour. Furthermore, with this waiver I expressly assume the risk of injury or death due to negligence by Citizens for a Better Eastern Shore, its agents, employees, members, officers, directors, staff, and any landowners, their families, employees, or tenants over whose land I ride for my own safety or for the safety of my minor child.

With the knowledge of the foregoing, and as an inducement for Citizens for a Better Eastern Shore to allow me to ride in the Between the Waters Tour, I hereby agree to waive or release any and all rights that I or my heirs may have to make a claim against Citizens for a Better Eastern Shore or any members of its Board of Directors, employees and participants, or any landowners over whose land I ride, arising from any damages, injury, or death which I might sustain. I further agree to indemnify and hold harmless all of the foregoing from any claims which I might make or which might be made on my behalf by others or which might be made against me by others, arising from riding in the Between the Waters Tour. Furthermore, I agree to indemnify Citizens for a Better Eastern Shore, its Board of Directors, members or employees, or any landowners, their families, employees or tenants, for any injury, death, loss or damage to any personal property which might occur during an event sponsored by Citizens for a Better Eastern Shore or held in its behalf or for its benefit, when such injury, death, loss or damage occurs on the property of a landowner.

By signing this waiver and release, I UNDERSTAND THAT I AM GIVING UP (WAIVING AND RELEASING) ANY RIGHT I MIGHT HAVE TO SUE OR MAKE A CLAIM WHICH I MIGHT HAVE OR WHICH MIGHT SUBSEQUENTLY ARISE OR OCCUR AGAINST CITIZENS FOR A BETTER EASTERN SHORE OR ITS MEMBERS AND PARTICIPANTS, OR ITS BOARD OF DIRECTOS, OR ANY LANDOWNERS, THEIR FAMILIES, EMPLOYEES OR TENANT, OVER WHOSE LAND I RIDE, FOR ANY INJURIES I MIGHT SUSTAIN WHILE BICYCLE RIDING OR PARTICIPATING IN A BICYCLE ACTIVITY, and that I AM INDEMNIFYING AND HOLDING HARMLESS, CITIZENS FOR A BETTER EASTERN SHORE, ITS BOARD OF DIRECTORS, MEMBERS AND EMPLOYEES, AND/OR ANY LANDOWNERS, THEIR FAMILIES, EMPLOYEES AND TENANTS, OVER WHOSE LAND I RIDE, FOR INJURING ANYONE ELSE WHILE SO ENGAGED. IT IS MY INTENT TO GIVE UP THOSE RIGHTS AND PROVIDE THE HOLD HARMLESS AGREEMENT, AND I DO SO KNOWINGLY AND VOLUNTARILY.
